## EK Law Section III.I. The Agenda for the Curia Regis

- 2. If a Curia notice has been sent according to East Kingdom Law, but another Curia needs to be held before the previously announced one, any items of business held over from the earliest Curia will be automatically added to the agenda of the subsequent Curia under "Old Business".

## II. The Crown

- B. Crown Tourney
  - k. All entrants must have Society memberships, which are valid at least through thirty days after the date of Crown Tourney. So long as the entrants meet the minimum membership requirements to enter Crown <u>Tourney-Tournament</u> as set forth by the Governing Documents of the SCA, Inc., The Crown may waive the requirement that entrants have Society memberships which are valid at least through thirty days after the date of Crown Tourney, on a case-by-case basis.

F. Major Kingdom Events Conflict

Should any group wish to host a Pikestaff Publishable event which would be within 100 miles of a published Crown <u>Tourney</u> Tournament, Coronation, or Twelfth Night, they must first obtain permission from the current Crown.

## IX. Awards

- F. Polling Orders
  - 6. The Kingdom Webminister shall create and maintain official Kingdom polling notification lists for each Polling Order, listed in this section; and shall, in cooperation with the Clerk of the Polling Lists, establish a verification system to ensure that only companions of a given Polling Order are granted access to that Order's polling notification list. Each Companion of a Polling Order is charged to keep the Clerk of the Polling Lists advised, in writing, of his maintain and update their current contact information on the polling notification lists and preference for method of receipt of pollings, and also to notify the Clerk of the Polling Lists should they he wish to become inactive, to resume activity, or to resign from the Order.

#### XI. Youth Combat Activities

- A. No person who has not attained his or her sixteenth (16th) birthday may be authorized in armored combat.
- B. No person who has not attained his or her fourteenth (14th) birthday may be authorized for fencing.
